The Familiar and the Unfamiliar Argument of the 30th EPF Conference in The Hague, April 2017

Dear colleagues,

it is with great pleasure that we invite you to the 30th conference of the EPF, which will take place in The Hague from April 6th to April 9th. The conference will be hosted by the Dutch Psychoanalytic Society, which was newly established in June 2016. We consider ourselves very fortunate that three formerly separate Dutch psychoanalytic societies are now united within the NPaV, and we are happy that the conference can be hosted under the lucky star of this successful integration.

The establishment of the NPaV, coincidentally touches on the general topic of the congress. We chose this topic because presently, and within a very short period of time, Europe must face immense political, economical and cultural challenges, and bear the high potential for conflict that calls into question previously familiar social structures. Within Europe's conception of itself cleavages and even ruptures have emerged, which not only affect the reflections and emotions of society as a whole, but of each individual citizen as well.

The causes of these ruptures can be explained by the rather cataclysmal shifts within external as well as internal life conditions. Due to the influx of refugees, which is at times inflated, increased national self-interests are generated. In this socio-cultural context, we must deal with a conflict between phantasies concerning the potential influence of the unfamiliar and wishes to conserve our own culture. Striving to work through this area of conflict, we, as psychoanalysts, bear our own specific responsibilities. Our knowledge of the influence of unconscious individual and social dynamics gualifies us to participate in political and scientific discussions, and compels us to intensify our research of the specific intrapsychic and interpersonal processes involved.

This is precisely the reason we would like to attend to the relationship between the familiar and the unfamiliar in different areas of practice inside and beyond the psychoanalytical treatment room. While translating the originally German title, we became aware of the fact that it was not possible to agree on a completely identical meaning in all three languages. Thus, the formulations we came up with are compromises, which all the while contain an unfamiliar element for the other language respectively and simultaneously evoke an ambiguous and perhaps unfamiliar comprehension within one's own language. Hence, the theme of the conference is already depicted in the dialectical tension between the different languages.

Despite these disparities, we would like to identify some fundamental features of the Familiar and the Unfamiliar, which should be equally valid for all cultures and languages.

The philosopher Ernst Bloch (1964) phrased the individual's developmental starting point concisely and clearly as follows: "Ich bin, aber ich habe mich nicht. Darum werden wir erst." (I am, but I don't have myself. Therefore we're only just becoming.)¹. Herewith, he refers to the existential necessity to reach out for the sake of getting in touch with one's own self. Indeed, this conception corresponds to psychoanalytic body of thought. As early as 1895, in his "Project of a Psychology", Freud alluded to the fact that human beings learn to cognize through the "Nebenmensch"2. Meanwhile, it has come to be psychoanalytical common knowledge that the infant depends on his "Nebenmensch", i.e. his mother and father, in order to develop his own self through emotional and cognitive communication. Likewise, we know that, depending on the parental capability to recognize the problem of other minds and to encourage mentalization/symbolization, the child's true self may emerge - or an alien and thus false self may develop. Both possibilities are subject to the presence of an Other, and inherently, alterity is a necessary condition for further mental development and identity formation. Against this backdrop, the maturing child may well sense a place of yearning within his image of an unfamiliar and remote world, even if this implies dealing with collateral anxiety. In this context, Bloch (1959)

termed the phrase "the beautiful unfamiliar"3. Thus, this faraway place and the unfamiliar is rendered attractive due to something dynamic, a motivation emphasizing one's own agency. A reversal to anxiety and resistance may however be evoked, if the foreign intrudes on the child or the adult, inducing fear of passivity or impotence which is experienced as a terrifying threat. In this case, the productive and creative of the unfamiliar is abandoned, and the individual, or, respectively, the specific group of persons, according to the individual situation, begins to fight the unfamiliar "intruder" with realistic or distorted defense mechanisms. Hence, the unfamiliar is no longer experienced as a rewarding enhancement, but rather as a danger to one's own identity. In this case, mental blockades are established within the individual or in the particular group of people. which are often based on a schizoid level of mental organization, drawing on primitive patterns of splitting as well as on non-differentiating friendenemy concepts. In our treatments as well as in our public demeanor, we, as psychoanalysts, are faced with the task of discriminating between the vital care of one's self (and its own) and the selflimiting rejection of the alien, which is based on fear of persecution.

According to the philosopher Bernhard Waldenfels (2006), the ambiguity of the Other as compared to the Self and its own can be examined on at least three levels: If the Other appears to be something exterior to one's own domain, as opposed to something interior, it refers to a place. If the Other is something belonging to someone else, and not to oneself, it refers to a claim. If the Other is experienced as something foreign and uncanny as opposed to the familiar, it refers to a kind of understanding⁴. As psychoanalysts we could agree with the philosopher, inasmuch as both entities are not secluded in themselves and the attributes "other/ alien" as well as "own" have a relational character. Ownness emerges only from disengagement and relation to the other/alien and both are intertwined in the intercultural relationship as well.

In the main lectures held by Sverre Varvin (Norwegian Soc), Franco de Masi (Italian Soc) as well as Fakhry Davids (British Soc) and Denis Hirsch (Belgian Soc), as well as in several panels concerning the theme of the conference, we would like to create a space for the intrapsychic and intercultural aspects of such an intertwined relationship. This includes, among others, examining our perspective on the relationship between European citizens and refugees, the increase of violence and terrorism against "the others", our acceptance or rejection of cultures perceived as foreign or "strange", as well as the "uncanny" and unfamiliar aspects within our own Self. It is also of great importance to elucidate mutual intelligibility between one's mother tongue and a foreign lanquage and the appropriate translations respectively, as well as verbal-symbolical interpretations in the psychoanalytic process. In addition, we plan a round table for an inter-disciplinary discourse on this issue.

Between familiar and unfamiliar: lost in psychoanalytic organizations

This Large Group provides a space for the emotional and experiential aspects not usually touched on in our scientific discourse. As analysts we are used to work under nearly solitary conditions, meeting with one other person at a time. But we also belong to larger groups and organizations, like our societies and institutes, and participate in conferences with many others such as this one. This Large Group aims to explore the thoughts, feelings, fantasies and projections that may emerge around these experiences and the theme of the conference, as it pertains to being in a crowded meeting with a large number of analysts and finding or losing ourselves between the familiar and unfamiliar.

Three consultants will be available to facilitate the group work: Shmuel Erlich (Israel Soc), Mira Erlich-Ginor (Israel Soc) and Pedro Gil Corbacho (Madrid Assoc).

This Large Group will meet twice and is open to all conference participants, including guests. There is no need to preregister.

Working Party on Psychosomatics Thursday 09:00h-12:30h and 15:00h-17:00h Chair: Jacques Press

Starting from a clinical point of view we would like to better apprehend the points of convergence between hypotheses concerning the somatization processes; these are often hidden behind different metapsychological theorizations. On the other hand, it is equally important to work on the basic differences between these theories. Our working party aims to work on these issues.

There will be two groups (in English) in The Hague, each one with two sessions, one in the morning, one in the afternoon. During the morning session, the presenter will speak of the two or three very first interviews with his / her patient. We will then discuss our hypotheses on the functioning of the patient, on our understanding of the mechanisms leading to somatic illness in this particular case as well as on the first transference – countertransference interactions.

In a second part of the morning session, the presenter will report the raw material of one or two sessions. In addition to the moderator leading the discussion, there will be a silent listener who will intervene at specific moments when central psychosomatic issues seem to emerge. We will explore how these moments relate to the initial hypotheses drawn from the first interviews.

After the lunch break, we will try to explore more in depth the transferential and countertransferential issues raised during the morning session and the way the group's dynamics reflect them.

Forum Working with Haydée Faimberg's ,Listening to Listening' method Wednesday 17:00h-20:00h / Thursday 09:00h-17:00h and Thursday 09:00h-17:00h / Friday 14:30h-16:30h Chair: Haydée Faimberg

We co-create a language to discuss differences and understand the presenter's work. We wish to overcome the idea that we accept the work of a colleague just because he works as 'me'. Often clinical material is heard from one chosen implicit basic assumption (recognised or not). It is part of our goals to train ourselves in listening not only to recognise the presenter's clinical assumptions but also to recognise our assumptions as well.

We shall try to understand from which theory we are listening to the presenter as well as trying to understand from which theory the presenter is listening to his patient and interpreting or not interpreting. We explore the impact that the theoretical assumptions of each participant have on the discussion itself. Common language refers to a way of understanding each other in the group, not to a project of working as psychoanalyst in a similar way. Though it might seem a difficult task, we feel it makes justice to differences instead of idealising sameness.

We are using the function of 'listening to listening', which was initially limited to the psychoanalytical listening in the session. By 'listening to how each participant listens to each other', the sources of misunderstanding (as a valuable tool) may appear and so we begin to recognise the basic assumptions of each participant (which might create, precisely, the misunderstanding).

The familiar and the unfamiliar in adolescence

Adolescence commences with the shock of the new, the child confronted by the radical unfamiliarity of his or her own sexually adult body. Adulthood is not unfamiliar, but the adult body had been previously the prerogative of the parents, the Other, the "not me", whose power included the capacity to generate life, to experience jouissance, and to protect the vulnerable child. If the Oedipal task has been faced, the possessive claim on or appropriation of one parent or another has been reluctantly surrendered, the grounds of sexual identity established, while parental protection has been maintained, for the duration of childhood. If the anxiety of separateness has been intolerable to the child, then the child who has lived in a timeless, idealized bubble of eternal narcissistic union to an inseparable adult is doubly shocked by the fact of life which is pubertal change. In all cases, there is a moment of radical and uncanny interruption. The bodily attributes of the adults who have been loved and hated, attacked or negated, identified with or merged with suddenly come alive and invade the self, disturb the body ego, change its boundaries, demand a reworking of the relationship to the parents, to reality, to the transience of life, and to culture.

The task is not small. It depends on a capacity for work as well as play, in order to relearn the limits of "me", the relation to the "not me", the reality of the separation and distancing from the adults, who have been up to then, the "we of me" as Carson McCullers' anguished and conflicted heroine protests in *A Member of the Wedding*. The programme follows the same structure as in previous years:

Thursday morning, 10:30h-13:15h

Two parallel clinical workshops, in English and French. A presenter will bring clinical material – analytic sessions - for discussion with the participants.

Thursday afternoon, 14:30h-18:00h

A clinical paper will be presented (Arjen Schut (Dutch Soc) *Perverse functioning in adolescence*), developing the theme of the congress from a clinical perspective, through an analytic case. A member of the forum discusses the presentation, followed by open discussion from the floor.

Friday morning, 11:00h-12:30h

Collective traumata and their traces in analysis

This paper focuses on the experience gathered from the psychoanalytical treatment of survivors of mass execution, as well as of their descendants. In order to reflect on this clinical material, we have drawn on psychoanalytical texts concerning the links between the individual, culture and history. Although "Massenpsychologie und Ich-Analyse" ("Group Psychology and the Analysis of the Ego") can be considered the most important work on this issue, our reflections strongly lean onto psychoanalytic reports of colleagues, on writings of survivors and their descendants, as well as on research on contemporary history, political anthropology, literature, etc..

From the very beginning, in his working hypothesis, Freud locates culture and the collective in the very core of the psyche, which thus bares traces of our ancestors' experiences.

With regard to this issue, the contributions of colleagues in our SPP-seminar have lead us to conceive the intertwining of the individual and the collective within the cure somewhat diversely, i.e. not merely in terms of duality and mutually exclusive dichotomies. In our opinion, the confrontation with a more complex interlinking of the individual and culture requires another mode of understanding.

In our ongoing reflections upon these issues in the forum we will examine the following:

- Are there any contemporary adaptations of the psychological trauma theory with regard to the mass executions in the 20th century?
- An exploration of the way the links between the patient's dissociation and the collective circumstances are enacted in countertransference and how they can be treated and interpreted. We believe that, before the historical event can be worked through collectively, it generally passes through a period of latency, which determines the modalities of the transference of experiences from one generation to the next. The nature and the function of this latency period, as well as the concurring psychological processes, remain to be described and explored. By discussing the above questions, we aim to broaden the discourse on the consequences of the "currant collective traumata" in contemporary Europe. We are faced with them in the treatment room, because in psychoanalysis, the individual subject's very essence is linked with the collective.

Forum »Free Clinical Groups« (FCG) Thursday 14:30h-18:30h Chair: Denny Panitz and Peter Wegner

This specific method of examining clinical material was developed by Wolfgang Loch in Tübingen. He has characterized the discussion of clinical material in groups by comparing it to the model of the prism effect: Like the light beam that, when funnelled through a prism, will reveal heretofore invisible parts and make them transparent. The group discussions will reveal thus far unmentioned and unconscious components of the patient and make him appear in his various parts and different nuances, thus enabling a deeper understanding of the psychoanalytic work.

This psychoanalytic method as a discourse oriented method, which aims at the mutual understanding between subjects, is therefore particularly well suited to facilitate a clinical understanding between different psychoanalytic schools and traditions. The group is not only interested in a psychoanalytic process but mainly in arriving at possible interpretations.

The initial presentation of the material ends at a point just before the first intervention or interpretation has been made. Only when the group itself has arrived at one or more possible interpretations, the presenter will show the rest of the session. Information about diagnosis, patient biography, the process, number of previous treatment hours and frequency of treatment will not be provided until the presented session has been discussed in its entirety that is only before the final discussion.

The independent clinical groups (FCG) in The Hague will consist of two moderators, one presenter, and a maximum of 15 participants. The clinical material may be chosen from psychoanalytic treatments in a variety of settings. The participants ought to come from different European societies.

Reflections on Freud's work "The Uncanny" SE XVII (1917-1919)

Sigmund Freud's work "Das Unheimliche". "The Uncanny" (1919) refers to the theme of the conference "THE FAMILIAR AND THE UNFA-MILIAR" in various ways and simultaneously addresses our concern about the threat of terrorist attacks in many countries. This fact immediately - and in a guite specific way - has lead to questions regarding the meaning of the concept of "The Uncanny". Freud elucidates this term from different perspectives. He begins by investigating its etymology and its literary illustration in E.T.A. Hoffmann's novel "Der Sandmann", as well as by the study of psychopathological states. Later, in his work "Bevond the Pleasure Principle" (1920). his reflections will induce diverse elaborations (i.e. the fundamental expansion of the term 'repetition compulsion'), thus giving rise to the various theoretical and clinical discussions, which have taken place in the past decade.

In the German language "uncanny" or "unheimlich" generates multifarious associations and connotations, which can scarcely – if at all – be found in other languages. For example, Marie Bonaparte's translation of "The Uncanny" into French was "L'inquiétante Etrangeté", which can be retranslated as "the disturbing foreignness". In the new edition of the Collected Works in French, "L'inquiétant" is "the disturbing". The meaning of the word "heimlich" or "clandestine" - in the sense of covert. secret. unobserved. hidden. undetected, tacit, furtive, obscure - is multifaceted in and of itself and becomes transformed into "unheimlich". "uncanny" in moments of fear. i.e. if we are faced with something threatening, horrible or gruesome. For instance, an "uncanny" feeling might befall us at misty site. Hence, we are no longer capable of understanding and judgment; even more so in the case of internal, subconscious processes. On the other hand, in German the word "heimlich", also contains the Germanic "heim", meaning native country, house, domicile; but - then again - this very house may become a place containing a secret.

Based on these arcs of suspense, we face various implications, which we are looking forward to examining together.

In English and German; contributions regarding "The Uncanny" in other languages are very welcome.

Ethical conflicts in contemporary psychoanalysis

Our divergences and convergences in Europe rest on different conceptions of psychoanalytic ethics, that is to say the principles and values that guide our practice. What are the ethical foundations of these practices within our analytic cultures and their historical context? How can our debate interrogate the development of contemporary psychoanalysis facing the current crisis? Is it relevant to insist upon a specifically psychoanalytic ethics, distinct from the ethics of care within the psychotherapeutic field? Our reflections will start from concrete situations and conflicts in our practice that raise questions as to the conception and goals of our work. This year our debate is centred upon the ethics of **Skype analysis**.

The ethics of Skype analysis: the familiar and the unfamiliar

What are the ethical questions raised by the growing practice of Skype analysis? How does the use of Skype render the familiar ethical debates unfamiliar? Can an entire analysis be conducted by Skype? What happens to the analytic setting both internal and external? What about the absence of the body? What are the implications of including Skype in a conventional analysis? These are only some of the ethical issues that we will debate together with our two speakers who will introduce the theme.

Ad hoc Group The Specificity of Psychoanalytic Treatment through Inter-Analytic Group Work Wednesday 15:30h-19:00h and Thursday 09:00h-18:45h Chair: Jan Abram

This new Ad Hoc Group originates from the Working Party on the Specificity of Psychoanalytic Treatment Today and constitutes two interconnected components of psychoanalytic research:

- For ten years it has been a Working Party (known as the Paris Group) that has been integrated into the research programme of the EPF.
- The research proposes a pioneering new psychoanalytic methodology for analysts to work in small clinical groups. The clinical exchanges between a diverse range of international analysts form part of the crucial experience for psychoanalytic research today.

The small clinical groups are made up of between 12 and 15 analysts from different analytic cultures who work for a day and a half on the same clinical material i.e. 3 consecutive sessions of a current analytic treatment presented by one analyst.

The methodology has evolved from the work of J. L. Donnet and R. Kaës. The presenter relates the essentials of the session content without giving any indication of the patient's biography or the course of the analysis. Once the first session has been presented the analyst remains quiet without responding to questions raised by members of the group. The fundamental rule of the group is that of psychoanalytic treatment for the patient i.e. to associate freely to the material. Thus the group 'constructs' the patient. During this work the two moderators hold and mediate the group's associations.

The basic idea is for each participant to articulate the unconsious derivatives, based on their conscious and unconscious basic assumptions, in order to further the inter-analytic work that constitutes a diffraction of the patient and analytic couple. Towards the end of the work, usually in the last meeting, the presenter shares their responses to the group process. This step enables the group, moderators and presenter to assess the validity of the inter-analytic group work in identifying the specificity of each psychoanalytic treatment.

In The Hague there will be 4 groups (French speaking and English speaking). Ad hoc Group on Exploring Training Process and Practice (ETPP) Wednesday 16:00h-18:00h and Thursday 09:00h-17:30h Chair: Françoise Labbé

In the Ad hoc Group on "Exploring Training Process and Practice (ETPP)", interested training and supervising analysts of all European psychoanalytic societies are invited to look at candidates in training and especially in supervision. In the presentation and discussion we want to follow the course of the whole training and want to investigate the strengths and weaknesses of the presented candidates at different stages of their training, also dependent of the institutional strengths and weaknesses.

This follows from a crucial result of the former ETEP-project: We have seen that all psychoanalytic supervision is embedded in an institution. The question then arises as to whether and how the progress of candidates, their strengths and weaknesses, are linked to specific institutional influences. One might say, supervision is an interface between a private relationship and an institutional process.

Therefore the ETPP-Ad hoc Group places emphasis on the meaning of the structure and the culture of an institute in which supervision takes place. Both structure and culture are essentially influenced by the specific training model of each institute, and therefore the presentation of supervisory material will be combined with the question: How do different training models interact with supervision and how does the institution further or hinder the progress of candidates?

The methodology will be as follows: A training and supervising analyst will present supervisory material in a small group of colleagues and the colleagues should concentrate on the implicit training model of the presenter and on the institutional influence as well. The idea is not to focus on what group members think the criteria of strengths and weaknesses should be, but on understanding what the presenter's ideas are. This is therefore also an opportunity for the presenter to try to set out his ideas and to reflect on them with colleagues, especially in relation to the institutional context.

Subject to the number of participants, there will be several small groups and each group will be moderated by a member of the ETPP core group.

Meeting the cultural other: familiar and unfamiliar aspects

The psychoanalyst's encounter with a culturally-different patient stirs up the familiar and the unfamiliar. On the one hand, as a human being the patient functions, consciously and unconsciously, in a similar way to the analyst, and hence is recognisable. On the other hand, differences between them linked to their cultural backgrounds bring in the unfamiliar, some of which will be easier to process consciously than others.

For instance, material may emerge that is repressed in the culture of one but given open expression in that of the other, bringing the return of the repressed and the uncanny. These elements may find their way into culture-related transferences and countertransferences, adding a layer of complexity.

Collective fantasies in the analyst about the patient's culture, including unconscious stereotypes, may also be present and projected onto the patient.

The process of migration itself might even affect parenthood and the identification processes in the second-generation patient. The access to symbolic references unavailable to their parents, will bring in complicated identifications where origins can become enigmatic lands of conflict between the familiar and unfamiliar difficult to work through.

All these factors may influence and complicate work with the culturally-different patient, but they are not widely addressed in our profession today. We will bring forward a range of material for discussion – clinical material, interchanges among psychoanalysts, and incidents from daily life in a world becoming increasingly multicultural – to start a clinical and theoretical dialogue about how psychoanalysis might best address these issues. The pre-conference Forum will consider detailed clinical material, with the Panel having a more theoretical focus.

"The elderly are someone else...."

It is familiar to all of us, that the elderly are the others. Denying that we ourselves are the elderly, at least for our patients, we are ignoring facts of life. Repressing, denying and not recognizing age related symptoms of illness and not being familiar with the own ageing process can be very dangerous in psychoanalytic relationships for patients, as well as for analysts and the process of transmitting psychoanalysis. Ignoring this process is destructive for generativity for example of psychoanalytic institutions. It is a challenge to trust and to have to trust in the younger generation.

Contributions in the forum will deal with these aspects giving clinical examples also for the process of mourning which is necessary when becoming aware that not only other people get old.

Treating patients who have killed: the importance of diagnostic clarification

Presenter: Massimo De Mari (Italian Soc) Chair: Carine Minne (British Soc)

Since 2000, when Leslie Sohn first held this workshop, the long-term psychoanalytic treatments of severely disturbed patients who have killed, have been presented at the annual EPF conferences. These are patients often psychiatrically diagnosed as suffering from Personality Disorders but who manifest psychotic states, particularly at the moments of killing. It is not uncommon for the severity of the patients' disturbance to be underestimated or even missed by clinicians. In this EPF workshop, we will continue the clinical discussions around the importance of diagnostic clarification, using current cases to illustrate. This will be presented in terms of the helpfulness of considering a single diagnostic entity. The importance of this diagnostic proposal in terms of assessing risk of enactment and treatment needs will be stressed. The workshop is based on the psychoanalytic work of an international group of clinicians based in forensic psychiatry and prison settings in different countries.

The familiar and the unfamiliar in psychoanalytic institutions. About stumblings of otherness

Speakers: Jasminka Šuljagić (Serbian Soc), Gábor Szőnyi (Hungarian Soc), Franziska Ylander (Swedish Assoc) Chair: Bernard Chervet (Paris Soc)

The aim of the Ad Hoc Group on Institutional Matters (IMG) is to explore matters concerning the implications and interrelations of two kinds of logic within psychoanalytic associations. On one hand, there is groupal logic, based on a fear of the unknown and of the foreign, the denial of otherness, and on the alienation in an idealistic mentality. On the other hand, we find singular logic which repeats and transfers to institutions reminiscences of the familiar and the unfamiliar in childhood, with some consequences such as estrangement and projection of the family model on the institution. The mix of both logics can create great conflictual complexity in the organization of psychoanalytic institutions, or a rupture between the familiar and unfamiliar, identified firstly in oneself and secondly in the institution.

To promote this reflexion, some criteria and parameters will be chosen and followed, such as the foundation of new groups and societies, the age of the societies, their specific organisations, inherent difficulties in psychoanalytical institutions, the care to be given when shaping new groups and during the training of individuals, the similarities and differences in problems occurring within different societies, going through the challenges of today's world, and highlighting individuality as well as democracy.

Psychoanalysis and University Saturday 11:00h-12:30h Chair: Franco Borgogno

The uncanny charm of psychoanalysis: Still "unfamiliar" in academia after all this time (1897-2017)? Experiences from different regions of the IPA

Presenters: Henrik Enckell (Finnish Soc), Charles M. T. Hanly (Canadian Soc), Patrizia Giampieri-Deutsch (Vienna Soc), Frances Thomson-Salo (Australian Soc / British Soc) Chair: Franco Borgogno (Italian Soc)

The 2017 Panel of the IPA-Committee "Psychoanalysis and the University" at the EPF Conference in The Hague will focus on the topic of the main Conference "The Familiar and the Unfamiliar", relating it to academia.

Coming from diverse psychoanalytic cultures as well as different regions of the IPA, the panelists Henrik Enckell, Charles M. T. Hanly, Patrizia Giampieri-Deutsch, Frances Thomson-Salo, and Franco Borgogno (Chair) will reflect on how psychoanalysis in academia remains quite "unfamiliar" or even "uncanny". Indeed, everybody in academia knows the name of our discipline; therefore, psychoanalysis seems very "familiar" at first glance. However, it is nevertheless difficult to transmit the essence of living psychoanalysis in academia, especially its technical peculiarity and uniqueness compared to other psychotherapeutic methods or counselling in general.

Furthermore, the past and current striving in psychoanalysis to establish its own tradition of research including the development of applicable methodologies is still "unfamiliar" to the scientific community in academia.

The Panel will also consider the diversity of the issue "familiar" versus "unfamiliar" occurring in different countries and regions of the IPA. Fruitful experiences in teaching and researching psychoanalysis are occurring within the frame of a broad range of different faculties in Australia and Canada as well as European countries like Finland or Austria. Nevertheless, it is not easy to bear the aura of "otherness" while maintaining the constraints of our discipline. Although the presence and impact of psychoanalysis in academia do not necessarily imply the implementation of training at the university, psychoanalysts have been working in previously mentioned countries like Finland or Austria to link training to academia. Finland has already succeeded in implementing the training at the university as a postgraduate program, whereas Austria is going to establish a program combining the training with an academic dearee.

Comments on the short presentations will be provided by discussants, reflecting on their own experiences at different university faculties as well as at their institutes of training.

The Committee on Women and Psychoanalysis of the IPA provide a framework for the exploration of topics related to issues mainly about women but also considering the relations between men and women, masculinity and femininity and currently includes issues concerning men. The particular approach of this Committee is to relate psychoanalytical thinking with the outside world and its problems and the socio-cultural point of view and through this the revision and updating of psychoanalytical concepts. We conduct psychoanalytical research into problems concerning the complex relations between categories of sexuality and gender and their implications for psychoanalysis.

We encounter "The Familiar and Unfamiliar" in the revolving situation with the great numbers of refugees who have come to Europe in 2015 and 2016. Especially women and girls are under specific gender related threats in their homelands, during the flight and also in the refugee camps in Europe. Gertraud Schlesinger-Kipp describes the project of Alexander-Mitscherlich-Institute in Kassel, Germany, where about 25 Psychoanalysts and Psychotherapists realized a psychosocial and psychotherapeutic approach in refugee camps in Kassel, especially with women who are searching shelter and asylum in Germany. They come mostly from Syria, Afghanistan, Iraq and Eritrea. The loss of identity, the pain of family conflicts, the gender specific causes of the flight as well as the deep irritation and at the same time hope through the more free life of women in Western country are touching the therapist and translator and demands a cultural- and gender sensitive approach. The limits and chances of sometime single possibilities of talks are presented together with Art therapist Mania Kramuschke who presents a case of a 16 year old girl.

Marianne Leuzinger-Bohleber (Sigmund-Freud-Institut) and Sabine Andresen (Goethe University) are responsible for the pilot project "STEP-BY-STEP" for supporting refugees in the arrival institution "Michaelis-Village" in Darmstadt. The project is based on the psychoanalytical trauma research as well as pedagogical concepts as "child-friendly space" which had been developed for children in refugee camps in Palestina. The interdisciplinary team of STEP-BY-STEP (around 60 persons) are closely cooperating with the professional and non-professional teams in the "Michaelis Village". One focus lies on supporting pregnant refugees and young mothers. Young female researchers such as Nora Hettich and Marie Teising will present this project.

How to write a psychoanalytic paper for The International Journal of Psychoanalysis
